These Terms of Service ("Terms") govern your use of Mycelium Gold Bitcoin (MGB) and related services provided by Mycelium Group Limited ("Mycelium," "we," or "us"). By using MGB, you ("User" or "you") agree to be bound by these Terms. If you do not agree with any part of these Terms, you should not use MGB.

Definitions

- "Mycelium" or "we" refers to Mycelium Group Limited, registered at 24th Floor, Al Sila Tower, ADGM Square, Al Maryah Island, Abu Dhabi, United Arab Emirates.
- "User" or "you" refers to anyone using MGB.
- "MGB" refers to Mycelium Gold Bitcoin, a secure physical bearer of public and private cryptographic keys used for managing cryptocurrencies or as a fashion statement.

MGB Description

MGB is made of 75% purity gold and serves as a secure physical medium for storing cryptographic keys. The purity percentage and weight of MGB may vary, and we do not guarantee their precise levels. MGB is designed to weigh approximately 1 troy ounce.

Document References

This document refers to two other documents: "The Technical Instructions" (Instructions) and "Handling Precautions" (Precautions). All three documents are published at 000.mycelium.com. These Terms, Instructions, and Precautions are subject to change and/or amendments. We strongly recommend downloading the current versions of these documents and keeping them for future reference.

Usage and Responsibilities

Using MGB is straightforward, but it is essential to follow these Terms, Precautions, and Instructions to reduce the risk of losing your protected information. You acknowledge that without your MGB, you will not be able to access the protected information it contains. If your MGB is lost, stolen, damaged, or destroyed, there will be no way to recover your protected information or access your cryptocurrency funds. Furthermore, if your information is compromised, unauthorized individuals may access your funds without remedy. It is crucial to follow the Precautions to avoid theft.

Tamper-Evident Seal

MGB comes sealed with a tamper-evident seal. Once the seal is removed, anyone holding MGB can gather sufficient information to gain unauthorized access to your funds. It is your responsibility to follow the Precautions to prevent unauthorized access.

Open-Source Development

We develop MGB and related services in an open-source fashion to enable testing and verification of their functionality and security. The Instructions provide all the necessary information to handle your information and funds without relying on our software.

Limitation of Liability

The liability we assume regarding the sale of MGB is limited to the security of the MGB itself. No software included with the package shares this responsibility. Bitcoin wallet agents also do not share responsibility for events occurring on a public blockchain where transactions take place. We do not create barriers to prevent the use of MGB with third-party software or services, but we assume no legal responsibility for such usage.

Agreement and Responsibility

If you do not agree with or understand any information in these Terms, Instructions, and/or if you lack the legal capacity to use MGB and manage cryptocurrency funds, you should not use MGB. If you choose to use MGB in a manner non-compliant with the Precautions, you are solely responsible for any resulting damage or harm.

Disclaimer of Damages
